Inspector Comments: Ensure to properly wash hands with soap and warm water prior to installing gloves and thus not cross contaminating other disposable gloves.

Observed employee handle raw meat and raw meat package and reach into glove container to install disposable gloves.

Violation Description: Employees are required to wash their hands: before beginning work; before handling food / equipment / utensils; as often as necessary, during food preparation, to remove soil and contamination; when switching from working with raw to ready to eat foods, after touching body parts; after using toilet room; or any time when contamination may occur. Gloves shall be worn if an employee has cuts, wounds, fake nails, nail polish, and/or rashes. Gloves are to be used for no more than one task. Employees are not to wrap or package leftover food using bare hands or unclean utensils. Hand sanitizers may be used after proper hand washing. Employees handling food must have fingernails that are trimmed, cleanable, and smooth. (113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f))

Violation Description: All food employees shall have adequate knowledge of and be trained in food safety as it relates to their assigned duties. (113947) Food facilities that prepare, handle or serve non-prepackaged potentially hazardous food, shall have an employee who has passed an approved food safety certification examination. (113947-113947.1)

7. PROPER HOT AND COLD HOLDING TEMPERATURES

Inspector Comments: Maintain cold holding temperatures of potentially hazardous foods at or below 41 degrees.
 Observed temperature of grated cheese at 48 degrees in prep table.

Maintain hot holding temperatures of potentially hazardous food at or above 135 degrees.
 Observed temperatures of the tops of numerous foods in steam table ranging from 107 to 126 degrees.
 Ensure to stir foods to maintain even hot holding temperatures. Manager states that foods are not kept in steam table longer than 20 minutes.

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

Observed quaternary ammonium measuring below 200 ppm in 3 compartment sink.

Violation Description: All food contact surfaces of utensils and equipment shall be clean and sanitized. (113984(e), 114097, 114099.1, 114099.4, 114099.6, 114101 (b-d), 114105, 114109, 114111, 114113, 114115 (a, b, d), 114117, 114125(b), 114135, 114141)
