Inspector Comments: FOUND DEAD BIRD PARTS DOWN THE AISLES.

Not In Compliance

Reference - SBCC - 33.0920 (d)(1)

Description: Dead poultry shall be removed from the cages at least once a day and immediately disposed of by one of the following methods:

(A) Placed in a fly-tight container or structure for proper off-site removal and removed from the premises at least weekly. Containers shall be kept clean

to prevent fly breeding.

(B) Placed in a disposal pit of approved construction.

#### 40K044 Disposal - Waste Egg

Comply by: 7/8/2015 Not In Compliance **Inspector Comments:** WASTE EGG BUCKETS NEXT TO EGG HOUSE IS OPEN AND ATTRACTING FLIES. BUCKETS MUST BE COVERED AT ALL TIMES.

Reference - SBCC - 33.0920 (d)(2)

**Description:** Waste eggs shall be disposed of by one of the following methods:

(A) Placed daily in the dead bird disposal;

(B) Placed in fly-tight containers or structures and removed from the premises at least weekly.

#### 40K142 Operations - Chemical

Comply by: 7/8/2015 Not In Compliance Inspector Comments: CHEMICAL LOG NOT BEING MAINTAINED PROPERLY.

Reference - SBCC - 33.0920 (e)(2)

**Description:** Whenever necessary, the fly population on the ranch shall be chemically controlled to prevent nuisances. Larviciding shall be kept at a minimum. Appropriate adulticides, including both sprays and baits, may be used to control adult fly populations.

#### 40K146 Operations - Fly Breeding Hazard

Comply by: 7/1/2015 Not In Compliance Inspector Comments: WET MANURE IN IN THE AISLES CREATING FLY BREEDING HAZARD. REMOVE ALL WET MANURE.

#### Reference - SBCC - 33.0912

**Description:** The accumulation, existence or maintenance of any substance, matter, material, or condition resulting or likely to result in the breeding of flies in an amount or manner such as to endanger public health or safety, or to create unreasonable interference with the comfortable enjoyment and use of life and property by others.

#### **Overall Inspection Comments**

RANCH IS APPLYING NEPROREX IN ALL HOUSES DAILY. CAN SEE THAT THE NEPROREX IS WORKING THE FLY LARVA IS MUTATED. RANCH DID NOT SPRAY THIS MORNING BECAUSE EQUIPMENT BROKE. RANCH MANAGER JUST GOT DONE FIXING IT AND WAS GOING TO SPRAY RIGHT AFTER BREAK. CHEMICAL LOG IS NOT BEING MAINTAINED ONLY SHOWING NEPROREX AND 1 ADULT SPRAYING A DAY. RANCH IS TURNING THE MANURE AND REMOVING THE WET MANURE. FOUND MORE WET MANURE SPOTS TODAY. RANCH MANAGER STATED THEY HAVE NOT GOTTEN TO ALL THE HOUSES TODAY BECAUSE OF EQUIPMENT FAILURE AND KILLING BIRDS THIS MORNING. WASTE EGG BUCKETS NEXT TO EGG ROOM ARE OPEN AND ATTRACTING FLIES AND MUST BE COVERED. WET MANURE SPOTS LOCATED IN THE AISLES IS CREATING A FLY BREEDING HAZARD. WET MANURE MUST BE REMOVED. IN ONE HOUSE FOUND 2 CHICKEN WINGS AND HALF A CARCASS OF A CHICKEN. NOV ISSUED. AMOUNT OF FLY BREEDING HAS NOT CHANGED SINCE MONDAY. MODERATE TO HEAVY.
