Pesticide log recorded use of Neporex on 9/5/12 in houses 1 - 5 and on 9/6/12 in houses 6 - 12.

Ravap used on 9/12/12 in houses 1, 3, 4, on 9/18/12 in houses 5, 6, 7, 8, and 10/3/12 in houses 1, 3, 4.

Heavy breeding observed in houses 5 - 12.

No active watering system leaks observed.

Follow up inspection on 10/11/12.
