Pesticide log recorded use of Neporex on 12/13/12 in all houses.

Ravap used on 12/11 in houses 1 - 6 and on 12/9 in houses 7 - 12.

No active watering system leaks observed.

Lime needed on wet manure from prior watering system leaks.

No violations observed.
