Adult fly population light on ranch at time of inspection.

Pesticide log recorded use of Neporex on 4/28/12 in houses 7 - 12, and on 4/29/12 in houses 1 - 6.

Evergreen sprayed daily.

No active watering system leaks observed.

Lime applied to wet manure from prior watering system leaks.

No violations observed.

Recommend cleaning dropping boards especially in the lower numbered houses.
