Adult fly population light to moderate on ranch at time of inspection.

Pesticide log recorded use Neporex on 9/5 in houses 1 - 5 and on 9/6 in houses 6 - 12.

Ravap sprayed on 9/18 in houses 5, 6, 7, 8, and on 9/12 in houses 1, 3, 4.

Evergreen sprayed twice daily as an adulticide.

No active watering system leaks observed.

Overhead spray/ misting system on during inspection.

Wet manure from prior watering system leaks not treated with lime.

No violations observed.

Recommend use of lime on prior watering system leaks, and use of Ravap.
