Violation Reference: SBCC - 33.0919(b)

Violation Description: The standards herein shall be interpreted to promote good fly control practices in accordance with recognized biological control practices to reduce the possibility of fly breeding. However, they do not preclude the use of pesticides when necessary or other good fly control practices as approved by DEHS. Additionally, DEHS may require any reasonable action necessary to insure fly control and to prevent a public nuisance.

Inspector Comments: Excessive fly breeding observed.

Overall Inspection Comments

Inspection found:

Adult fly population moderate to heavy on ranch at time of inspection.

Pesticide log recorded use of evergreen as an adulticide daily. Neporex sprayed on 5/20 in houses D, F, G, H and on 5/22 in houses A, B, C.

Excessive fly breeding in wet manure.

No active watering system leaks.

Wet manure from prior watering system leaks not treated with lime.

Follow up inspection on 5/31/12.
