**Violation Description:** Food facilities that prepare, handle, or serve nonprepackaged potentially hazardous food, except temporary food facilities, shall have an owner or employee who has successfully passed an approved and accredited food safety certification examination as specified in Sections 113947.2 and 113947.3. There shall be at least one food safety certified owner or employee at each food facility. No certified person at a food facility may serve at any other food facility as the person required to be certified pursuant to this subdivision. The certified owner or employee need not be present at the food facility during all hours of operation.

**17K806 Permit - Food Handler Cards**

**Violation Description:** Applicability. Except as provided herein, no person shall work or allow the employment of any person as a food handler within this jurisdiction except when such food handler possesses an unexpired, unsuspended, unrevoked food handler card or a certificate after passing an approved and accredited food safety certification exam as described in § 113947.1 of the Health and Safety Code (food safety certificate). Food handlers are exempt from this requirement for 14 calendar days following the date of employment if working under the supervision of a person holding an unexpired, unsuspended, unrevoked food safety certificate.
